## DESK WITH VIEW

**Design: Anjum Razvi, ASID**  
**Razvi Design Studio, Rancho Peñasquitos**



Interior designer Anjum Razvi's client did not like the layout nor finishes in the home office the previous owner had created from a spare bedroom in her Rancho Bernardo home. So she gutted the old office and created a clean, simple and functional new space with loads of file drawers and storage space.

"It was very important for my client to face her garden when she sat at the desk so we 'floated' the desk out from a wall and oriented it toward the west-facing garden. To solve the afternoon sun problem, we installed a Silhouette blind remote-controlled from the client's desk.

"Custom-built birch cabinetry with some rounded corners was used for her main work area, stained to resemble a medium cherry. For the desk-top, we used two interesting laminates — a neutral and a green — to create an eclectic mix."

Razvi created additional painted built-in storage in what had been a closet and installed recessed lighting for both the work area and the walls to highlight art collected in the client's travels.

Walls are painted a buttery yellow and the carpet is a textured neutral.

### GETTING THERE

**1. LA JOLLA 3770 Caminito Sueño:** Interstate 5 north to La Jolla Village Drive exit. Turn left (west) and proceed to La Jolla Scenic Drive. Turn left (south) to Caminito Deseo. Turn left (east) to Caminito Sueño.

**2. RANCHO SANTA FE 5940 Lago Linda:** Interstate 5 north to Via De La Valle and exit east. Turn left on Paseo Delicias, right on La Granada, right on Avenida De Acacias. Home is on the corner of Lago Linda and Avenida De Acacias.

**3. RANCHO BERNARDO 12913 Guacamayo Court:** Return to Paseo Delicias and continue east (becomes Del Dios Highway). Turn right on Via Rancho Parkway and continue southeast to Interstate 15 south. Exit Pomerado Road left and proceed south to Guacamayo Court. Turn right.

**4. LAKE SAN MARCOS 1759 La Plaza Drive:** Return to Interstate 15 north. Take Highway 78 west to San Marcos. Exit Rancho Santa Fe Road. Turn left (south) and proceed to Lake San Marcos entrance at San Marcos Drive. Turn left (east) and to San Marino Drive. Turn left and proceed over bridge to La Plaza Drive. Turn right.

**5. FALLBROOK 4374 Vista Del Pacifico:** Return to Highway 78 east to Interstate 15 north. Exit at Pala Road (Highway 76). Turn left (west) and go to Old Highway 395. Turn right (north) on Wilt Road. Turn right (east) on Peony Drive. Turn left on Vista Del Pacifico.
